What is MLA?

The MLA essay format has been designed by the MLA. MLA stands for Modern Language Association of America. The aim of this association is to increase the strength of language and literature.

The MLA essay format has been published in the 8th edition of the MLA handbook. In this handbook, you can find the specifications related to formats for essays and academic papers. The MLA format for essays and academic papers is very similar. The handbook also contains information on how to cite using the MLA citation style.

Overview of MLA essay format

Now that we know where the MLA essay format came from, let us see the format for both academic papers and essays. Before going into detail about the format, you need to know 5 format guidelines. These guidelines are

Use font size 12 and set font style to Times New Roman

Set page margins to 1"

Use double line spacing instead of single line spacing

For each new paragraph, you use, set up a 0.5" indent

The headings should have case capitalization

These 5 guidelines are the basics that should be remembered when writing an essay in MLA essay format. Next time you find yourself asking, 'What guidelines should I use when I <u>write my essay for me</u> in MLA format?' remember the above 5 guidelines.

Now let us move on to the header. The header is located on the first page of the paper in MLA essay format. The header is also left-aligned and contains the following information;
Full name
Name of course instructor or supervisor
Name of course with the number
The due date for the assignment
After you add these 4 to your header, then we write the title, just like essaywriter.college . The title is located in the center of the page right below the header. Remember to use title-case capitalization. The running head of your essay should just contain your last name and the page number. The MLA essay format states that the running head should be right-aligned so make sure you do that
Like the references page in APA essay format, the MLA essay format has a 'Works cited' page. This page is usually put at the end of the essay and contains all the outside sources you have used in the essay. These outside sources can either be primary sources or secondary sources.
If the references in your 'Works cited' page is more than one line, then you should use a hanging indent. A hanging indent is an indent that is applied to all lines except the first. This rule applies to all other essay formats as well
It is up to you if you want to use headings or subheadings in your MLA formatted essay. However, if you do end up using them then you need to remember the format for them. In MLA essay format, the headings are all aligned to the left. They need to be written and title case and should not be ending with a full stop. Remember to bold the headings so they are prominent
The subheadings are also left-aligned and written in the title case. However, subheadings are not bold-faced. Instead we subheadings are italicized. Many writers do <u>essay writing</u> by following these rules.
MLA essay format also specifies how you should label any tables and figures used in the essay. For tables, there should be a caption that shows the source for the table. This caption is put below the table. The table is labeled with a number and this label is bold-faced

Figures, just like tables, are also labeled and numbered. The label is bold-faced and is placed below the image. The caption of the image usually has the word figure shortened to 'fig' and then the number of the image. Provide the source of the picture in the caption. Remember to include the sources of your tables and figures on the work cited page.
