It is useful to write a summary or an assessment of the two subjects one why one. In the first body paragraph, the summary of the first subject will be written. You should make sure to include the strongest points instead of many points while writing the summary. The same will be done for the second subject in the second paragraph.

After giving the related information to the reader regarding both the subjects, it is then the turn for the final and last body paragraph. Here, you will finally analyze and compare the two subjects and their salient points. They will be discussed such that they contribute to the main thesis statement and the topic.

The structure will be as followed:
Introduction
Body paragraph
Summary of Subject A
Summary of Subject B
Comparison of concepts and characteristics of A and B
Conclusion

Head to Head

In the head to head format, the writer goes forward with the main points of the subjects rather than the broad concepts. These points of comparison will each take a different body paragraph. The beauty of this type of format is that it lets you see one subject in light of the other. On the other hand, there are some <u>paper writing service</u> for students who can easily put their thoughts on paper. Each paragraph will have a topic sentence that will state explicitly the area of comparison and also show how it strengthens the main thesis or the claim of the essay. Each topic of comparison will lead you to discuss various dynamics between the subjects through the similarities and differences.

The structure will be as followed:
Introduction
Body Paragraph
Comparison of subject A and B under Topic A
Comparison of subject A and B under Topic B

Comparison of subject A and B under Topic C

Conclusion

Final Word

It is important to show the readers the road map in the introductory paragraph, as the method you choose affects the structure, the type of comparison, and the depth of analysis. The conclusion will restate your thesis and the salient points to close the essay.
